Breast Cancer

Definition of breast cancer:

Cancer that forms in tissues of the breast. The most common type of breast cancer is ductal carcinoma, which begins in the lining of the milk ducts (thin tubes that carry milk from the lobules of the breast to the nipple). Another type of breast cancer is lobular carcinoma, which begins in the lobules (milk glands) of the breast. Invasive breast cancer is breast cancer that has spread from where it began in the breast ducts or lobules to surrounding normal tissue. Breast cancer occurs in both men and women, although male breast cancer is rare.

Breast Cancer Prevention (PDQ®)

Who Is at Risk?

Besides female sex, advancing age is the biggest risk factor for breast cancer. Reproductive factors that increase exposure to endogenous estrogen, such as early menarche and late menopause, increase risk, as does the use of combination estrogen-progesterone hormones after menopause. Nulliparity and alcohol consumption also are associated with increased risk.

Women with a family history or personal history of invasive breast cancer, ductal carcinoma *in situ* or lobular carcinoma *in situ*, or a history of breast biopsies that show benign proliferative disease have an increased risk of breast cancer.

Increased breast density is associated with increased risk. It is often a heritable trait but is also seen more frequently in nulliparous women, women whose first pregnancy occurs late in life, and women who use postmenopausal hormones and alcohol.

Exposure to ionizing radiation, especially during puberty or young adulthood, and the inheritance of detrimental genetic mutations increase breast cancer risk.

Senate Approves SGR Bill. No Delay for ICD-10!

On April 14, 2015, Congress approved legislation to repeal the Medicare Sustainable Growth Rate (SGR) formula. The bill passed the Senate at 92-8 giving further momentum towards the October 1, 2015 implementation deadline of ICD-10 with all major hurdles now cleared. The time is here – is your facility ready for October 1, 2015? Is your staff ready – not only coders – physicians and other qualified health care professionals, front desk personal, clinical personal, etc. Everyone is involved and should be trained in this new process of diagnostic coding.

SUNSCREEN

A very important aspect of maintaining healthy skin and preventing skin cancer is the regular use of sunscreen. It is important for you to understand the proper usage and type of sunscreen to apply to gain the best results.

WHAT ARE THE EFFECTS OF SUN EXPOSURE TO THE SKIN?

CANCER – These cancers include Melanoma, Basal Cell Carcinoma, and Squamous Cell Carcinoma.

SUN SPOTS – small reddish spots, and others are all related to prolonged, unprotected sun exposure.

SUNBURNS

WRINKLES, LEATHERY SKIN – Excess time in the sun also leads to early aging of the skin.

WHAT TYPE OF SUNSCREEN SHOULD BE USED?

Sunscreen with a SPF (Sun Protection Factor) of at least 30 should be used. Also, make sure it is protective against **both UVA and UVB** radiation.

WHEN SHOULD SUNSCREEN BE APPLIED AND HOW?

Sunscreen should be applied whenever you think you are going to be exposed to the sun for more than **20 Minutes.** Sunscreen should be applied to dry skin about **30 minutes before going outdoors**. It needs to be applied to all areas of the skin, especially the hands, arms, neck and face. Sunscreen should be **reapplied after swimming or perspiring heavily**.

Extra care needs to be taken when you are on concrete, snow, sand or water, because these surfaces will reflect light, leading to increased exposure to the harmful UV light from the sun. Also, UV light can penetrate water to a few feed and being underwater should not be considered protection from the sun.

WHAT SHOULD YOU DO IF YOU HAVE AN ALLERGIC REACTION TO SUNSCREEN?

Some patients will be allergic to one of the sunscreen products on the market. If this is the case, do not stop using sunscreen, but switch to a different type of sunscreen. However, continue to use a sunscreen with a SPF of at least 15, and one that is protective against both UVA and UVB radiation.

ARE TANNING BOOTHS OR PARLORS SAFE?

Absolutely not. The light used in these booths will also lead to premature wrinkling and leathering of the skin and skin cancer. These should not be looked upon as safe alternatives to sunbathing.
