

Opioid CME requirement start July 1, 2019. This law requires any board-licensed health care practitioner applying for or renewing a controlled substance registration to have completed two hours of continuing medical education (CME) on opioid addiction and prescribing in the previous two years. The Indiana Professional Licensing Agency will post a list of CME providers whose offerings meet this requirement on its website, www.in.bov/pla/medical.htm. Proposed bylaws/standing rules amendments -

Reimbursement for budgeted ISMA expenses when funds are reimbursed by another source Annual Conference – A proposal was made about changing the wording of the registration fees of the ISMA It was proposed to add this line to the standing rule – unless financial support is provided by another source.

The standing rule would say:

The registration fees of the ISMA President, Vice President, Recording Secretary, Treasurer, Immediate Past President, Parliamentary Advisor, Corresponding Secretary, Med-A-Scoop Editor/Website Development Officer, Conference Chair and Vice Chair would be complimentary unless financial support is provided by another source Complimentary registration fees are to be budgeted as a conference expense.

Complimentary rooms for the conference are to be assigned as follows: One room for the Conference Chair and Vice Chair; Conference Registration and Conference Ways and Means Chair; assigned representative from AAMA. ISMA CODING CORNER

ICD-10-CM 2019 codes were released by the Centers for Disease Control and Prevention to be used from October 1, 2018 through September 30, 2019. This year, there are 473 code changes, including 279 new codes, 143 revised codes, and 51 deactivated codes.

Fifty-one of the codes in the "T" section of ICD-10-CM which contains codes for injuries, burns, poisonings and toxic effects, foreign bodies, and complications of surgical and medical care, have been deleted and replaced with new codes that will allow more accurate coding and specification. Some examples are:

Intra-muscular abscess following a procedure, initial encounter – T81.42XXA Sepsis following a procedure, subsequent encounter – T81.44XXD Stitch abscess following a procedure – T81.41XXS

These are the base codes which require seventh characters to indicate the encounter: Initial "A", subsequent "D", or sequela "S." As these are seventh characters, placeholder "X" must be used.

Other changes of ICD-10-CM codes for 2019 are new codes for coding neoplasms specific to the eyelid, including canthus. Example: Malignant melanoma of right upper eyelid, including canthus – C43.111. Also, new codes for Diseases of the Eye and Adnexa – Unspecified blepharitis right eye, upper and lower eyelids – H01.00A and left eye, upper and lower eyelids – H01.00B.

The American Medical Association has released **335** code changes for 2019 to reflect scientific and technological advances in medical, surgical, and diagnostic services. Key changes include:

Remote patient monitoring codes

Interprofessional internet consultation codes

New and revised codes for skin biopsy and fine needle aspiration biopsy

Adaptive behavior analysis and central nervous system evaluations, including psychological and neuropsychological testing.

Healthcare Common Procedure Coding System (HCPCS) codes for 2019 have only a few minor changes, mostly related to coding of diabetic devices.

Since reimbursement is based on the most current ICD-10-CM, CPT, and HCPCS codes, it is important to utilize the most recent publications of these references, whether printed or online.

Stay tuned for future issues based on CMS' proposal to revise the Evaluation/Management Policy for new and established outpatient services. With the release of the Medicare Physician Fee Schedule (MPFS) final rule for 2019, providers will see significant changes in the reimbursement of these services.


