## ISMA CODING CORNER - Medical Marijuana

A hot topic in the news continues to be medical marijuana or cannabis and the pros and cons to treat a number of health issues. First of all, what is the difference between cannabis and marijuana?

"Cannabis" refers to all products derived from the Cannabis sativa plant with the main substances THC and CBD. "Marijuana" refers to parts or products from the cannabis plant that contain substantial amounts of THC which is the substance responsible for the effects of marijuana when used.

What I found to be interesting is the growing number of states that allow reimbursement of medical cannabis or marijuana by Workers' Compensation Insurance. Currently six states permit medical cannabis access and reimbursement for their employees: Connecticut, Minnesota, New Hampshire, New Jersey, New Mexico, and New York. There are six states where reimbursement is prohibited: Maine, Massachusetts, Florida, North Dakota, Ohio, and Washington.

It is illegal to have possession, manufacture and distribute in the state of Indiana after much debate at the Indiana Statehouse. CBD oil derived from hemp but low in THC (10% CBD and no more than 0.3% THC) is fully legal in Indiana when recommended by a physician for a qualifying condition. The FDA has determined products containing THC or CBD cannot be sold legally as dietary supplements and food items that have THC or CBD added to them cannot be sold legally in interstate commerce. However, individual states can depending on that state's laws and regulations.

Most insurers currently do not cover CBD oil, even when a physician prescribes it. And more and more physicians are prescribing CBD oil due to the benefits as a treatment with conventional medications. One prescription medication, Epidiolex, containing CBD oil, is FDA-approved for treating a rare form of seizures related to epilepsy, Lennox-Gastaut syndrome or Dravat syndrome. Marional, Syndros, and Cesamet which contain synthetic substances of THC, are approved by the FDA as well as Dronabinol and Nabilone used to treat nausea and vomiting caused by chemotherapy in cancer patients. Dronabinol can also be used to treat patients with HIV/AIDS for loss of appetite and weight loss.


# Rita's Rules... as Parliamentary Advisor

What is Parliamentary Procedure? It is a set of rules for conducting business at meetings and public gatherings. ISMA uses Robert's Rules of Order Newly Revised.

# **Purposes of Parliamentary Procedure**

- 1. Gives every member a chance to be heard.
- 2. Allows everyone to participate.
- 3. Establishes and maintains order in a meeting.
- 4. Prevents confusion when discussing a meeting's agenda.
- 5. Keeps the meeting moving towards its goals.

In each future issue we will look at how Parliamentary Procedure helps get things done.



#### **Procedure Manual Tidbits**

There were seven delegates and one alternate voted to represent Indiana Society of Medical Assistants. These representatives of the ISMA have agreed to go to the national conference in October, 2022 and attend the AAMA House of Delegates.

In our Procedural Manual (located on the Website), under Documents you can find Tips for being a delegate. Delegate packets should be received before our September meeting. Make sure to keep these safe and bring to the National Conference. At our September meeting, we will go over the packets and any of the new proposed bylaws with the ISMA members and see how they would like the delegates to vote.

The following should be reviewed by all delegates:

#### **DELEGATES AND ALTERNATES**

Please study your entire Delegate's packet very carefully so that you will be informed on all issues to be presented in **YOUR** House of Delegates. After you receive your registration packet check to see when the credentials desk will be open and plan your schedule to include all required meetings and activities. Webster defines a delegate as "A person given power or authority to act for others".

This is a serious responsibility - ARE YOU PREPARED?????

#### **TEST YOURSELF WITH THESE QUESTIONS:**

- 1. Have you STUDIED all of the material contained in your delegate's packet?
- 2. Have your discussed all items in your delegate's packet with your state officers and as many members as possible?
- 3. Do you know how the Reference Committee works?
- 4. Do you know how to present a motion properly? You must write it out exactly as you present it and give it to the Speaker and Secretary as quickly as possible.

#### **ADDITIONAL TIPS**

- 1. To LISTEN and THINK OBJECTIVELY are the most important duties you have as a delegate. Consider all issues for the good of the entire association, not just from the standpoint of one individual, district or state. You were elected to represent the Indiana Society of Medical Assistants. It is your duty to report back to your members. At the same time, you should re member to keep an open mind. Base your decisions on the deliberations of the House, not on a preconceived opinion.
- 2. Parliamentary procedure is designed to let a majority accomplish its ultimate goal within a reasonable time. Be prepared to express your views, and then be gracious if your opinion does not prevail. Learn to abide by majority rule. This is the basis of our democracy.
- 3. Reference committees are for **EVERYONE.** These committees provide an opportunity for members to express opinions and hear the opinions of others. Everyone is urged to attend these meetings, but you, as a delegate are obligated to do so.
- 4. **BE PROMPT.** Attend all sessions, but feel free to move about the room if necessary.

# **Explaining ECGs**

The heart has an electrical conduction system made up of electrical cells. These cells respond and transmit the electrical impulses to the neighboring cells. Five main structures make up this conduction system.

**Sinoatrial Node**- also known as the SA node, is more notably known as the heart's pacemaker. It is located in the superior wall of the right atrium.

The atrioventricular node- (AV node- is located at the base of the interatrial septum. When the SA node fires off its impulse, it reaches the AV node. It moves VERY SLOWLY through this node to allow the atrial chambers time to finish contracting and move the blood into the ventricular chambers.

**Bundle of HIS -AV bundle** in the upper interventricular septum, when the impulse leaves the AV node, it moves through the bundle into the **right and left bundle branches**. The impulse enters both left and right branches to allow the impulse to hit both left and right ventricle.

The branches split into many **Purkinje fibers**; these fibers transmit the electrical impulse quickly to the ventricular cardiac cells to help the ventricular chambers contract.

The cardiac cells cycle in three different states: **Polarization, Depolarization, and Repolarization**.

I explain this to my students: If someone is about to run, you cannot usually tell, but you can see someone actively running and notice when someone is out of breath from running. That is the same with polarization, depolarization, and repolarization in an ECG reading. Polarization is the resting stage- they are about to run. You do not see it on the ECG. Depolarization is the discharge impulse, they are running, and you can see it on the ECG. Repolarization is the recovery stage, you can visually see when someone is recovering from running, and you can see the recovery on the ECG.

#### Summary of ECG active:

The baseline of the ECG: Polarization is happening- we are preparing to run.

**P wave**: is the atrial depolarization; this is when the impulse is fired from the SA node to the AV node. The atrial chambers contract and the blood moves into the ventricles.

**The QRS complex** is the ventricular depolarization and the atrial repolarization. AV node fires into the bundle of His, and then the impulse makes its way through the left and right branches and into the Purkinje fibers. The heart's ventricular chambers contract and push the blood out of the heart.

**T wave:** Ventricular repolarization- the recovery from all this action potential.
