#### ISMA CODING CORNER

2022 is quickly approaching and time for the updates for the CPT codes. The 2022 CPT code set has 405 total changes: 249 new codes, 63 deletions, and 93 revisions. With the increase of demands for innovative care, such as digital health services as we have experienced during the pandemic, five new codes have been assigned to support innovation in these services: 98975, 98976, 98980, and 98981. These codes can be used to report therapeutic remote monitoring which has increased in popularity during the COVD-19 pandemic.

New CPT codes are now available for care management of patients with a single chronic condition. Previously, healthcare providers were reimbursed only for patients with multiple chronic conditions. The new codes are 99424, 99425, 99427 and better align with Medicare guidelines.

Two new COVID-19 vaccines are released - 91300 and 91301— Severe acute respiratory syndrome coronavirus based on dosage amount.

New vaccine administration codes for COVID-19 based on dosage amount:

0001A - first dose - 30 mcg/0.3mL

0002A - second dose - 30 mcg/0.3mL

0011A - first dose - 100 mcg/0.5mL

0012A – second dose – 100 mcg/0.5 mL

This is a first for vaccine codes to enable the tracking and documentation of each vaccine dose and its administration as the vaccine is free to the patient. It also allows documentation of counseling provided to patients or caregivers in the electronic medical record.

The AMA offers a vaccine code finder resource to its members to help identify the appropriate CPT code combination for the type and dose of COVID-19 vaccine provided to each patient.

A reminder that you cannot bill for COVID-19 vaccinations if that is the only service provided. You can charge for the office visit if the COVID-19 vaccination is given during an office visit or additional medical or other services are performed during the office visit.
