2022 Proposed AAMA Bylaws Amendments and Resolutions at the House of Delegates were:

22-01

Article IX – Nominations and Elections, Section 1, Nominations, A 1-2

Wording additions:

Each member nominated must be an active member present at the current House of Delegates session. Members of the Nominating Committee cannot run as a trustee or officer while currently serving of the committee.

After discussion, the Reference Committee on Bylaws recommended that Amendment 22-01 be adopted. The vote was in favor and passed.

22-02

Article XV – House of Delegates, Section 4B

Proposed wording:

Special meetings of the House of Delegates may be held at the call of the Board of Trustees by written or **electronic notice** sent to each member of the House of Delegates at least **14 days** in advance of such meetings.

After discussion, the Reference Committee on Bylaws recommended that Amendment 22-02 be referred back to the Bylaws Committee for further clarification. The vote was in favor of the amendment being referred back to the Bylaws Committee.

22-03

Article X11- Board of Trustees, Section 6. Management Steering Committee *Proposed wording*

The Management Steering Committee shall consist of the President, Vice President, Immediate Past President, Secretary-Treasurer, **Speaker of the House, and Executive Office Leadership.**

After discussion, the Reference Committee on Bylaws recommended that Amendment 22-03 be referred back to the Bylaws Committee for further clarification. The vote was in favor of the amendment being referred back to the Bylaws Committee.

22-04

Article VI -Membership, Section 3. Privileges

Proposed Wording:

Active and **AAMA** Life Members who are CMAs (AAMA) holding current status are eligible to serve as officers and trustees. Any Active, **AAMA** Life or **Associate** member may serve as a Delegate or **Alternate or on an AAMA Committee.** Privileges on a Society and Chapter level will be determined by those entities respectively.

After extensive discussion, the Reference Committee on Bylaws recommended that Amendment 22-03 be adopted. The amendment did not pass due to the lack of a 2/3 vote.

22-05

Article XV – House of Delegates. Section 2C (1)

Proposed Wording:

Delegates and Alternates shall be Active, AAMA Life, or **Associates members** who membership has not be revoked, as delineated in Article VI, Section 4.

Since Amendment 22-04 was defeated, this amendment was not voted upon since it was contingent upon the passing of 22-04.

Note: The changes of the AAMA Bylaws do not affect the ISMA Bylaws. Therefore, there will be no changes to our current ISMA Bylaws.

ISMA CODING CORNER

This article is Part III covering the ABC's of Laboratory Coding which focuses on the CPT coding changes for 2023. The AMA released 393 changes to procedure codes: 225 new codes, and 75 codes deleted with 93 codes revised. The most significant changes relate to the Evaluation and Management codes which will be addressed in the next issue. Many of these code updates are relevant to oncologists with a new code for laparoscopic prostatectomy that uses robotic assistance to remove the prostate (55867). The only specialty with no coding or guideline changes for 2023 is anesthesia.

There are several new laboratory codes for procedures performed on patients with cancer or those being tested for cancerous conditions. The list is lengthy, so just a few of the more familiar are discussed here:

- 81441 identification of inherited bone marrow failure diseases: Fanconi anemia (inherited bone marrow failure syndromes, such as, Diamond-Blackfan anemia and the BRCA2, BRIP1 FANCA series)
- 81449, 81451, 81456 targeted genomic sequence analysis panel for solid organ neoplasm
- 81451 targeted genomic sequence analysis panel for hematolymphoid neoplasm or disorder
- 87468 and 69, 87478, and 87484 define various infectious agent detections related to bacteria, fungi, viruses, and parasites. Antigen tests detect the presence of a microorganism directly to quickly diagnose an infection without waiting for the patient to produce antibodies in response to the microorganism.
- •87467 Hepatitis B surface antigen detection

There is also a new Category III code, 0739T, ablation of malignant prostate tissue by magnetic field induction. This code requires reporting after January 1, 2023. Category III codes reflect new technologies, procedures and/or services. For reimbursement, the medical provider is required to submit the operative report, letter of medical necessity, and a copy of the FDA approval letter to support the claim.



In the October/November 2022 Med-A-Scoop, this section discussed the 5 general types of motions. In this edition, we will address the main types of votes and when a motion requires a majority or a 2/3 vote.

TYPES OF VOTES:

- **By Voice** (The most common type of vote): The President asks those in favor to say 'aye' those opposed to say 'no'. Any member may move for an exact count.
- **By General Consent:** When a motion is not likely to be opposed, the President says, "if there are no objections...". The membership shows agreement by their silence, however, if one member says, "I object," the item must be put to a vote.
- **By Division or Rising:** Members raise their hands or stand. It does not require a count unless the President so desires.
- **By Ballot:** Members write their vote on a slip of paper, this method is used when secrecy is desired or numerous members are on the ballot, for easier counting.

MAJORITY VOTE

The basic requirement for adoption of a motion by its members, with a quorum, is a **Majority Vote.** A **majority** is more than half of the votes cast by persons legally entitled to vote, after taking blank votes and abstentions into account. **Majority does not mean 51%.**

Example: In a situation with 500 votes, the **majority** = 251 votes (one over half) not 51% which = 255 votes)

A **majority** is any number larger than one half of the total (Legal Votes Cast) minus (Blank Votes Cast) plus (Illegal Votes Cast). *Please note that illegal votes cast by legal voters are taken into account in determining the number of votes cast for purposes of computing the majority.*

2/3 VOTE

A 2/3 vote is generally not taken as a voice vote, but rather as 'By Division or Rising' count. To calculate a 2/3 vote: divide the number of votes by 3 and then multiply by 2.

Generally speaking, a 2/3 vote is required for adoption of any motion which:

Suspends or modifies a rule of order already adopted, i.e., Standing Rules.

Prevents the introduction of a question to consideration.

Closes, limits, or extends the limits of debate.

Closes the nominations or the polls.

Takes away membership or office

Specifically, the ISMA Bylaws require a 2/3 vote conferring a Life or Honorary membership by the Board of Directors or when amending any Bylaws.


TIE VOTES

A tie vote is a lost vote, since it is not a majority. However, the President, as a member, can vote in the affirmative or negative, causing the motion to be adopted or rejected accordingly. Similarly, in the case of a motion requiring a two-thirds vote, the President can vote in the same manner.

The following page is a guide for calculating both Majority and Two-Third Votes

Majority Vote: More than half of the votes cast by persons legally entitled to vote, excluding blanks or abstentions, at a regularly or properly called meeting at which a quorum is present. Source: Robert's Rules of Order Newly Revised, 12th Edition

The Heart House

The anatomy of the heart is very overwhelming when you are learning so many things as a new medical assistant. Then adding the physiology of the heart, some may want to cry.

For the flow of blood remember we read English left to right, the heart pumps the opposite right to left. As for the structure of the heart think of it as a house. Let's start with the key parts of the heart.

Right Atrium / Left Atrium
Right Ventricle / Left Ventricle
Septum
Aorta
Pulmonary Artery/ Pulmonary Vein
Superior/ Inferior Vena Cava
Tricuspid Valve
Bicuspid Valve (Mitral)
Aortic Valve
Pulmonary Valve

Atria the plural form of Atrium looks similar to Attic, which just like the attic is the top of your house – the atrium is the top of the heart. Ventricles are the lower chambers of the heart, much like the basement of the house. The left ventricle is the largest chamber/room. The septum is the tissue wall that is between the chambers, much like the walls in a house.

Superior/ Inferior Vena Cava both flow into the atrium. Superior Vena Cava is the blood that comes from the head and upper body so maybe you collect rainwater on the roof of your house and let it add into your water tank. Inferior Vena Cava is all blood from the lower part of your body similar to water from the city's main water line to your house.

Valves are one-way doors into rooms. There are four valves; the Pulmonary valve is an entrance into the pulmonary. The aortic valve is an entrance to the Aorta. For the last two think countdown: 3,2; <u>Tri</u>cuspid, <u>Bi</u>cuspid. The tricuspid is the valve between the Right Atrium/ Right Ventricle and the Bicuspid is the valve between the Left Atrium/ Left Ventricle.

Pulmonary Artery and Pulmonary Vein are like one-way hallways from the heart to the lungs. The pulmonary artery is the ONLY artery that holds deoxygenated blood, while the pulmonary vein is the ONLY vein that holds oxygenated blood. Pulmonary Artery is the hallway to the lungs to get the oxygen and the Pulmonary vein is the hallway back to the heart with the oxygen.

The Aorta the largest blood vessel in the body, is the chimney pushing the blood back into the body system. Thinking of the heart as a house works well if you are pairing together the physiology of the heart because now the house is built, we need to add electricity to it.

Dr. Sokol also describes hearts as houses. Dr. Rozanne Sokol is the founder of *Your Health Is on Your Plate*. "Think of the heart as having plumbing, electricity, and carpentry." "Diseases of the heart can usually be traced back to some problem in one of these systems. In other words, some heart problems are due to the plumbing, others to faulty wiring, and still others to either the material itself or how it is put together.

"Heart attacks happen in the plumbing. Blood vessels that surround the heart provide it with its very own blood supply. If blood cannot flow easily through those vessels, the heart muscle will not receive the oxygen it needs to function."


