

ISMA CODING CORNER

This is a continuation of the article published in the August-September 2023 issue of MAS. This article will focus on the ICD-10-CM codes that are assigned for patients, including health care professionals. It is interesting that there are so many ICD-10-CM codes to identify the different levels of stress.

Z73.3 – This code is assigned for stress that is not documented as more specific by the healthcare provider.

Z60.9 – Stress related to social environment

F43.0 – Acute stress reaction

F43.9 – Reaction to severe stress of unspecified nature or cause

R45.7 – State of emotional shock and stress, unspecified

R56.3 - Stressful work schedule

Health care workers are at a higher risk of workplace stress than other occupations. Some of the most common causes of stress in healthcare workers include:

Understaffing

Lack of resources

Lack of sufficient training or skills

Shift patterns

Heavy patient loads and long shifts

Unsociable hours (this is defined as hours outside work that go beyond usual working hours (whether day or evening/night shifts)

Lack of personal fulfillment from work or job

Stressful and emotional situations in caring for sick patients

Exposure to human suffering and death
