
I would like to encourage all ISMA members to become active in your district chapter along with your State Society. We need each of you to make our State and local districts a success.


I want to thank everyone for the cards and prayers during the ordeal with my fractured left hip.

ISMA CODING CORNER

Once again, healthcare billing fraud is a major concern with insurance providers, particularly as reported by Blue Cross-Blue Shield. Incident-to billing is defined as services meet all of the requirements billed under the supervising physician's NPI number (National Provider Identifier) created by the Centers for Medicare and Medicaid Services (CMS). An example: A general practitioner diagnoses a Medicare patient with hypertension and diabetes in January. Patient returns for follow-up visit in April and sees the nurse practitioner. The patient at that visit complains of knee pain which is a new problem. The nurse practitioner sees the patient for this visit. Although the physician is in the office, the NP evaluates and treats the patient for the new problem.

Some examples of healthcare fraud cases:

- A federal judge convicted a Maryland physician on five counts of healthcare fraud for summiting more than \$15 million in false claims to Medicare and a commercial insurer.
- A North Carolina lab owner overcharged Medicaid for unnecessary drug tests.
- An ambulance company owner was sentenced to 16 years in prison and ordered to pay \$388,648 in restitution for his role in Medicaid fraud in Massachusetts.
- A pain clinic owner in Virginia was ordered to pay \$4 million dollars for billing Medicare and Medicaid for non-medically necessary controlled substances.
- A physician in the St. Louis area who owns multiple urgent care centers in that area, as well as one of his office managers, are facing federal healthcare fraud charges.
- The owner of a Whitter, California-based medical clinic pleaded guilty to his role in a scheme that fraudulently billed Medi-Cal for \$5 million in services that were never performed.
- Optimus Health agreed to pay more than \$470,000 to settle improper billing allegations.
- Four medical staffing companies agreed to pay \$475,000 to settle allegations they submitted false claims to Medicare. (Locations not identified.)
- Sparrow Health System based in Lansing, Michigan agreed to pay \$671,310 to settle allegations that violated the False Claims Act by misuse of "incident-to billing." (Incident-to-billing is defined as billing of outpatient services, such as a nurse practitioner, physician assistant, or other non-physician provider whether the patients are new or established patients with new problems.

The Certified Medical Assistant (CMA-AAMA) proves their knowledge, skill and education of the difference between fraud and abuse. Fraud is an i**ntentional** deception that results in unauthorized payment of a medical bill. Examples of abuse are errors in billing of processing claims, unbundling (although this can be considered fraud in some cases), billing patients more than their copays as this is considered balance billing, charging a patient a duplicate fee. (Example: The patient is seen for the flu but documentation indicated the patient was treated for pneumonia).
